### Declaration of intent regarding the implementation of REACH\*

Dear Sir or Madam,

We thank you for your enquiry regarding compliance with regulation (EC) No. 1907/2006 (REACH). We are committed to meeting our legal obligations under REACH.

As foundry we provide your company with castings that as “articles” in accordance with art. 3.3 of the REACH Regulation are not subject to registration. Under normal and reasonably foreseeable conditions of use, these articles are not expected to release any substances.

Casting products that we manufacture as „downstream user“ based in the EU, consist largely of substances that are bulk goods, which were registered by our suppliers. In the rare cases, where we use substances from non EU countries for the manufacture of our products and therefore as an “importer” are subject to registration requirements, we will ensure that these are fulfilled – either by registration via a sole representative in the EU or by registration through us.

As far as article 33 of REACH regulation is concerned, we would like to communicate the following information:
